EXECUTIVE SUMMARY

The year being reported was a very rewarding year for the Foundation. The Foundation was able to implement over 75% of the approved work plan for the year 2022. Although there were few challenges but with the support of the Board we were able to surmount some of them. The following major activities were carried out, inspite of the vicissitudes experienced.

The 6th Board of Trustees (BOT) meeting was hosted by Mr. JoelAidamebor on the2022. The meeting approved the work plan, reviewed the external auditors report and commended the Project team for sustain and improving on all areas of her intervention. The TB programme continued with low cost activities like community visitation and sensitization of patients on the need for drug adherence. The Foundation had community sensitization and school interventions in five LGAs on irregular migration and trafficking in persons, etc.

The Adolescent and Youths Reproductive Sexuality Health (AYRSH) intervention with technical and material inputs from The Challenge Initiative (TCI) and the Ministry of Health Edo State continued in three LGAs: Igueben, Esan West and Etsako West. About 20,000 young persons were reached with Life Planning for Adolescents and Youths (LPAY) through text messages and accessed services.

On community mobilization and capacity strengthening for good governance, JOSEF moderated activities in 3 Civic Groups and supported the activities of the Concerned Ekpoma Eminent Stakeholders Forum (CEESF) to have series of community interventions on security, unmotorable roads, rape cases and human rights abuses.

Due to the rescheduled academic calendar for schools, the foundation carried out the expanded project on addressing the Girl Child Dropout Syndrome in Schools (AGCIDS) and Forced Engineering Studies (CAFES) against children Oasis Group of School Ekpoma. We had only two sessions. Our messages on the ills of irregular migration, sexual education, career planning etc. reached over 100 students.

The 4th Annual Lecture to mark the Feast Day of St. Josémaria Escriva Foundation (JOSEF) took place at Chosen Hotels, Ekpoma. The lecture titled, "Beyond paper qualification: Reinventing entrepreneurial skills as alternative to fighting poverty was eruditely delivered by Prof. Mrs. Esther Idialu of Ambrose Alli Univeristy Ekpoma. This is also part of our efforts to impact on the community and also create awareness about the Foundation's activities. Participants were drawn from the Academia, policy makers, religious and traditional rulers, students, security agencies etc.

30 Teachers in public primary schools in Esan Central Local government area took part in the Teachers for Effective Delivery (TESD) Project aimed at improving the quality of teaching and learning in schools. The project involved re-training 30 Teachers on the design and use of Teaching and Learning Materials in schools. The Project was funded by TY Danjumah Foundation. Some materials for the design of Teaching and Learning Materials (TLMs) were presented to 10 Public Primary schools were the teachers were drawn from.

Member of the Project Team and volunteers took part in over 10 capacity building centered on different thematic areas of the Foundation's work. The trainings were in Lagos, Calabar, Benin City, Lagos, Ekpoma and Abuja. Through the support of the British Council / European Union, the Foundation had a five months training and mentoring sessions on Strategic planning and Finance management. The training helped to update the Foundation's policy documents and records.

The British Council/ EU EU-ACT Challenge Fund project implemented by the Foundation was concluded in October 2022. The Foundation carried series of activities aimed at actuallising the theme of the project which was Empowering the Youth to Stimulate Participatory Democracy at Community Level in Edo State,

JOSEF was actively involved in the activities of the Edo State Management and Technical Teams on Sexual and Gender Based Violence. The Foundation did community sensitization, and case identification. At the moment the Foundation is currently handling two cases of SGBV in Edo Central LGA.

The annual Widows and vulnerable support programme of the foundation still took place. With the kind disposition of some individuals we were able to facilitate the support of 250 persons during the 2021 festive period. We thank them. Finally, the Foundation was able to survey her 200" x 200" project site along Ukhun Road, Esan West LGA. We intend coming up with a building plan and getting it registered with relevant government ministries.

In 2021, a total of Seventeen Million, Seven Hundred and eighty three Thousand, Five Hundred and Seventy-One Naira, Sixty Four Kobo only (17,783,571.64) was realized as Project Funds while the sum of Ten Million, Six Hundred and Ninety Four Thousand, Eight Hundred and Twenty-Two Naira, Twenty Kobo only (N10,694,822.44) was expended on various projects. Balance carried forward is Seven Million, Eighty Eight Thousand, Seven hundred and Forty Nine Naira, Twenty Kobo only (N7,088,749.20). The high balance is the 1st and 2nd Tranches of the BU/EU Project which commenced in December, 2021. The Foundation's accounts for the year 2021 was audited by a firm of Chartered Accountants and certified that the books of accounts were kept in line with best accounting practice.

Appreciation: We wish to express our appreciation to God Almighty for 2021. For his great help and support. We thank the Board of Trustees for their support, advice and suggestions. We thank our partners (TYDF, BC/EU, NSCSR, CONGOs), numerous friends and well-wishers who continue to support our activities. We thank the Project Team and Volunteers (Past and Present) for their unalloyed cooperation and commitment towards the activities of the Foundation in 2021. We equally appeal for greater support and commitment in the years ahead.

TUBERCULOSIS ACTIVITIES

Introduction

The Foundation offered psychosocial support to patients, monitored drug adherence, conducted Advocacy, Community and Social Mobilization (ACSM), identified and referred fresh cases for screening and also linking patients to care. We partnered with the TB Control Officer Esan West LGA and Institute of Human Virology, Nigeria. We interacted with nine (9) health facilities in 2021. The extent of work was limited due to the effect of COViD 19 Pandemic and funds. We commemorated the 2021 World TB Day through market campaigns (fliers) highlighting the causes and possible remedies.

2021 WORLD AIDS DAY (WAD): DECEMBER 1, 2021

Introduction

Josémaria Escriva Foundation had an online campaign to commemorating the 2021 World Aids Day (WAD). The online flyers were shared in all social media platforms of the Foundation. Project team members and volunteers were advised to also share in their separate platforms in addition to other youth friendly platforms identified. The campaign messages centered on the causes of HIV infections (like unprotected Sexual Intercourse with an Infected Person, use of unsterilized sharp objects - Needles, Razor blades, Clippers etc, transfusion of an unscreened blood to a Sick Person and transmission of HIV from an infected Mother to her Child during Delivering, Breast Feeding and during pregnancy; also care and treatment of positive cases.

COMMUNITY MOBILIZATION AND SENSITIZATION AGAINST HUMAN TRAFFICKING AND IRREGULAR MIGRATION IN EDO CENTRAL & EDO NORTH SENATORIAL DISTRICTS.

Introduction

Sensitization and outreaches were made to 4 LGAs due to the effects of Covid 19 and paucity of funds. The focus was to educate community members / students on the ills of irregular migration. During the CAFES session at the schools, issues of irregular migration were integrated to the sessions. Also, we commenced the process of registering with Networks on Human Trafficking in Nigeria like Civil Society Organization (CSOs) Working in the area of Trafficking in Persons, Child Abuse and Labour (NACTAL). Also, a team of researchers form Action Ald, University of Benin, Benin City and University of Ibadan, Oyo State engaged the Foundation to be part of s study to establish the Pull and Push factors of trafficking in persons in Esan West LGA. We had Focus Group discussion and interaction with key informants. They applauded the foundation on the level of commitment to fight agaist irregular migration in Edo State

Introduction

As a member of both State and National coordinating bodies on COViD-19, JOSEF continued to create awareness on COViD 19. The focus of our intervention was on the following areas.

- 1. Production of a Public Service Announcement (PSA).,- in English language, Pidgin and Esan. The jingles were shared on social media and aired on Ray Power Radio and some CD sellers in Ekpoma, Auchi and Igueben.

ADOLESCENTS YOUTHS SEXUALITY AND REPRODUCTIVE HEALTH (AYSRH) - The Challenge Initiative Project.

Introduction

The Adolescents Youths Sexual or Sexuality and Reproductive Health (AYSRH) Programme under the Edo State Ministry of Health (Department of AYSRH) was fully implemented by the Foundation with technical support from The Challenge Initiative (TCI). The project provided AYSRH and Life Planning programmes at grassroots, to reach out to adolescents and young persons (15 to 24 years), parents, guardians and other stakeholders in Esan West, Igueben and Etsako West LGAs in the area of reducing unsafe sex and abortion among young persons and access to youth-friendly information and services. The Programme ended in September 2021, however, the Foundation still continued with other activities - Inreaches and Outreaches.

Activities:

- i. Retrained of 45 Social Mobilizers in the three LGAs (15 per LGA) on modern issues in reproductive health, conducting Referrals using Go cards and challenges associated (if any).
- ii. Attended three Technical Working Group Meetings in Benin:
- iii. A total of about 37,470 youths and adolescents were reached with AYRSH messages.
- iv. Conducted 21 Inreaches and 18 Outreaches in designated Primary Health Care Centre and communities

Next Steps

- i. Demand generation activities in the 3 LGAs (Esan West, Igueben and Esan Central).
- ii. Intergenerational dialogues in selected communities in the 3 LGAs.
- iii. Continue with social mobilization activities in Esan West, Igueben and Etsako West LGAs.

EDO CENTRAL SENATORIAL AGCIDS / CAFES PROJECT

Introduction

The expanded project on Addressing the Girl Child Dropout Syndrome in Schools (AGCIDS) / Children Against Forced Engineering Studies (CAFES) Project seeks to address: Rise in school dropout amongst young persons in the senatorial district (2018 & 2020 Baseline Survey), Low self-esteem, poor parenting and counseling on career path, lost socio-cultural values and increase in drug and substance addiction amongst young persons, leading to sexual immorality and poor reproductive health consciousness. It is hoped that it will help in building the capacity of young persons through life skills training and mentoring, build inner strength and good choices, good peer pressure, entrepreneurship/skills development and improved knowledge on human trafficking and migration issues.

Activities

CAFES sessions in Ujoelen Grammer School, Emaudo Secondary School, Eguare Secondary School, Oasis Group of Schools and AAU Secondary School Ekpoma. The team was able to cover the balance three modules out of the eight modules in the CAFES intervention plan of action.

JOSEF ANNUAL LECTURE SERIES

Introduction

The 3rd Edition of Josémaria Escriva Foundation's Annual Lecture Series to mark the Feast Day of St. Josémaria Escriva was held on Tuesday 29th June 2021 at Ekpoma. The efforts aimed at creating awareness about the Foundation's activities. The theme for the 2021 Annual Lecture Series was Rethinking the Dilemma of Wealth without A Source and Its Security Implications for Nigeria was delivered by Prof. Marshall Azeke of Ambrose Alli University, Ekpoma.

There was full compliance with NCDC regulations. The members of the Board, the Chaiman of the occasion Mr. Peter Pacqueens Aisagbonhi, the Oba of Somorika Oba Sule Idiaye, representatives from security agencies in Esan West LGA, Opinion leaders, Students (Secondary and Tertiary), Youth Groups, TYDF, TCI, Development partners, CSOs to mention but a few were in attendance. A total of One Hundred and Seven (107) persons attended the event.

Nature of Programme

The Programme for the day was divided into four phases.

Phase 1- Lecture: There was a lecture on the theme Rethinking the Dilemma of Wealth without A Source and Its Security Implications for Nigeria was delivered by Prof. Marshall Azeke of Ambrose Alli University, Ekpoma. The lecture identified several factors like lost values, greed, satanic influence ec that encourage the negative quest for wealth amongst young persons which has led to high rate of criminality, avoidable deaths, disregard for customs and traditions and less premium for life. The lecturer advised that people should ensure that the source of their wealth should not be against societal norms and practices and there is value for labour even though it might take some time.

Phase 2 - Panel Discussions: Mr. David Aire from NTA Abuja moderated this session. The panelist were young persons who are mostly affected by this waive. The panelist agreed that the poor state of infrastructure, unemployment and misplaced values are some of the reasons for the increasing rate of criminal tendencies and quest for wealth by all means even if it warrants taking the lives of their dear ones like parents, and closed relations. They described all as vanity since most of then are unable to sustain the wealth and end up taking hard drugs and at times committing suicide.

Phase 3 – Oath Taking by the BoT: The oath was administered on behalf of the Chief Justice of Edo State Hon. Justice J. I. Acha by Hon. Justice U.I Erameh (Resident High Court Judge Ekpoma). The following members were physically present Prof M.A. Izibili, Prof. Mrs E. Ifidon, Mrs. R.I. Obasanmi RN, Bishop (Dr) Mon Igbinosa and Comr. Obasanmi Jude (Ph.D)

Phase 4 – Presentation of Books: The Chairman of the Occasion, Mr. Pacqueens Aisagbonhi presented some books to the Foundation. As a way of encouraging the schools in attendance, these books were donated by the Foundation to five secondary schools in attendance.

Lessons Learnt

- i. The event was an eye opening to the need for regular enlightenment on topical societal issues and developing advocacy messages.
- ii. Attendees were strategically selected to capture the target stakeholders. This facilitated a robust engagement during the panel conversations.
- iii. Efforts should be made to sustain the quality and standard of the lecture series.
- iv. The presentation of the communiqué at the end of the dialogue and onward distribution to all relevant stakeholders and social media platforms was a plus.
- v. Live Streaming of the events on our Facebook page was nice as it enabled some persons who were not present to follow the activities.

vi. Need to partner with some strategic stakeholders and partners to host future lectures. This will help in addressing the financial burden on the Foundation and expanding the audience scope.

Next steps

- i. It is expected that more funds would be raised to sustain the annual lecture series.
- ii. A Youth version will be implemented when the schools resumes this is to enable us capture their opinions as they are the worst hit in this emerging pandemic.
- iii. Identify and work with other stakeholders.
- iv. Have a round table conversation of the outcome of the event (Communique issued).

TEACHERS FOR EFFECTIVE SERVICE DELIVERY, ESAN WEST LGA (TESD PROJECT)

Introduction

The Teachers for Effective Delivery (TESD) Project aimed at improving the quality of teaching and learning in 20 Public Primary Schools (PPS) in Esan West Local government area by 2021 was fully implemented. The Project involved teaching 40 Teachers in the design and use of Teaching and Learning Materials in schools. The Project was funded by TY Danjumah Foundation. TYDF also presented some materials for the design of Teaching and Learning Materials (TLMs) to 20 schools in Esan West Local Government Area as at project Close out in December, 2021.

Activities

- 1. Advocacy Visits to stakeholders: State Urban Basic Education Board (SUBEB), Head of Local Government Administration Esan West, Esan West Local Government Education Authority Secretary, Nigeria Union of Teachers Esan West LGA Branch.
- 2. Selection of 20 Public Primary Schools and 40 Benefiting Teachers (2 teachers per school).
- 3. One Day sensitization and training for twenty (members) of the School Based Management Committee (SBMC).
- 4. Project Flag-Off and 6 Practical Training Sessions.
- 5. 20 PPS were presented with items to be used in the design of TLMs in their Schools).

- 6. Conducted two Monitoring and supervisory visits of 40 Participants in their schools.
- 7. Stepdown Training by the 40 Teachers. 40 Teachers conducted stepdown training for other teachers in their various schools.
- 8. Close out Event and award of certificates.

Deliverables

- a) 112 teachers developed the skill of identifying materials that can be used as TLMs
- b) Pupils got interested in learning supported by TLMs which enhanced pupils retainership.

EU-AGENTS FOR CITIZEN-DRIVEN TRANSFORMATION PROGRAMME (EU-ACT)

Brief on the Intervention

Josémaria Escriva Foundation was among the 20 CSOs identified by the British Council to be part of the EU-Agents for Citizen-driven Transformation Programme (EU-ACT) Programme. The Goal of the EU-ACT programme is: 'Inclusive, effective and accountable CSOs are influencing development in Nigeria'. The Purpose of EU-ACT is: 'CSOs are credible drivers of change in sustainable development'. Therefore, the EU-ACT sought to contribute to this Goal and achieve this Purpose by: a) Strengthening the capacity of Nigerian CSOs and Networks in the EU programme to effectively implement projects and engage in policy processes, and b) strengthening Nigerian CSOs and Networks to develop an appropriate, efficient and gender responsive civil society regulatory framework.

There was capacity assessment of the Foundation and areas where the organisation was lacking where identified. To fill these gaps, series of workshops (both physical and virtual) were organised by EU-ACT and JOSEF took active part in all the training programmes held in in Benin and Abuja. Some of the areas covered were Proposal writing, Monitoring and Evaluation, Gender and social inclusion, Project Circle management, financial management, Social media and organisational visibility, Resource mobilisation and fund- raising, Advocacy and lobby, Social Research and Analysis, CSOs Knowledge Management, Strategic Planing and workplan development

There was also a call for expression of interest for the Challenge Fund, Development Fund and Strategic Opportunities Fund. JOSEF expressed interest in the Development Fund project based on her competencies. At the end, the Foundation's proposal on Empowering the Youth to Stimulate Participatory Democracy at Community Level in Edo State was approved for funding. The Project is for 9 months (December 2021 to August, 2022). We have already commenced implementation with social mapping and advocacy visits to some stakeholders in the project area.
