In 2017, advocacy and awareness campaign on malaria causes, symptoms, transmission, treatment and prevention was carried out in Egoro-Amede community, Esan West LGA. Test for malaria and drugs were administered, and also Mosquito treated nets were distributed.

150 community members were sensitized on malaria causes, symptoms, transmission, treatment and prevention.

113 Long Lasting Insecticide Nets were distributed.

23 Positive patients got malaria drugs.

100 fliers were distributed.

Resolutions

1. It was resolved from Egoro-Amede's group that stakeholders will meet for proper education and that awareness will be created.
2. It was resolved from Irukepken's group that they will formally meet with the Edionwele for proper introduction.
3. It was resolved from Emaudo's group that a body will be set up by the affected communities to monitor and apprehend those perpetuating the act.
4. It was resolved from Emiala's group that they will meet with the elders and stakeholders in the community to raise fund and workmanship for the set project.
5. It was resolved from Ukpenu's group that a letter will be sent to the H.O.S so that he can help talk to those in charge to evacuate the drainage.
6. It was also resolved that more effort will be put in so that members can be committed in the various groups.

Impacts

1. 4 Speed breaks constructed in Emiala Road and Ujoelen Roads to help school children.
2. With the help of the civic group members are now able to engage in constructive dialogue with political parties.
3. 100 Members of the Civic Groups have also been impacted by engaging in community development works.
4. It has also created a cordial relationship between the members and community.

NIGER DELTA INSTITUTIONS CIVIL SOCIETY MONITORS

TYPE OF REPORT: MONITORING OF NIGER DELTA INSTITUTIONS IN EDO STATE.

Introduction

Josémariam Escriva Foundations was contracted by LITE Africa to monitor the Niger Delta Projects. The exercise was carried out from November 1, 2017 to December 15th, 2017. It involved monitoring project executed by the Ministry of Niger Delta Affairs, Niger Delta Development Commission and Edo State Oil and Gas Producing and Development Commission

No. of Projects Monitored: 27 Projects were monitored in Edo State

Observations:

1. Most of the Projects were either abandoned
2. Host communities were most times not contacted before the sitting of the projects.
3. Most of the projects were road projects (fresh construction and rehabilitations)
4. Some commissioned projects were not in use.

Recommendations:

1. Need for community participation.
2. Increased funding.
3. Proper NEEDs assessment to be made before the sitting of the projects.

Report Anti Human Trafficking Intervention in Esan West LGA

Introduction

After attending a capacity building on issues of trafficking in persons, our organization was able to commence processes of educating people on the ills of illegal immigration. With the kind Technical Support from Society for the Empowerment of Young Persons, a training and inauguration of Esan West Anti Human Trafficking committee was set. .

Members of the committee were drawn from the palace and other stakeholders.

Activities

1. 20 persons nominated from the various communities were trained.
2. Trained 20 Members of the Task Force Team
3. Familiarization and advocacy visit to the Palace Chiefs was made members. Over 30 Chiefs got a brief on issues surrounding trafficking in persons. The visit enabled us to thank the Highness for nominating them to serve in the task force. Also, briefed the highness on the outcome from the two days training held and solicited for support for most of the task force activities that will soon commence.
4. Elder J. A. Ilenre was nominated to serve as Task Team Head while Chief Eboehi Akhabue to serve as Secretary. Josémaria Escrivá Foundation will continue to provide technical supports.
